

## SoundStorm Access Fund 2020/21 Application Form

SoundStorm, lead partner for the Bournemouth, Christchurch and Poole Hub, is committed to ensuring that young people have access to opportunities to progress in music and believe that personal circumstances should not be a barrier to progression. As part of our inclusion strategy we offer financial support to contribute towards the costs of progressing your musical journey.

As the impact of the Covid 19 crisis continues to unfold, the Hub recognises that many more families will be faced with financial challenges; in response, we have significantly increased the Access Fund to enable many more students to progress their musical ambitions during these unprecedented times.

To be eligible to apply for financial assistance the student must be aged between 5 and 18 and be **resident or attending a school within BCP** (further criteria apply, in line with SoundStorm's Access Policy\*). You can apply for up to £450 however this does not guarantee you will be awarded the full amount.
